1:03 PM= President Jim Kilbreth of Spartanburg High: a. Open the business meeting of the SCTCCCA.

b. Reminded all members present that a new slate of officers will be nominated and voted on next year.

1:07= LF Sanders of Bell Street Middle:

a. Read the minutes of the winter clinic. The minutes were approved as written by President Kilbreth.

b. Gave the following financial statement-For 1987= Tookiin \$3348.69, took out- \$1603.05, balance-\$3385.31.

- 1:09= Vice-President Ed Boehmke of Eastside High presented the Coach of the Year awards.
 - a. Cross Country: Girls' Open- Delmer Howell, Mauldin High; Boys' 3A- Ted Whitaker, Hilton Head High; Boys' 4A- Jim Kilbreth.
 - b. Track: Girls' 1A- LaVerne Knox, Blackville-Hilda High; Girls' 2A- Ron Sullivan, Ninety Six High; Girls 3A- Herbert Glaze, Beaufort High; Girls 4A- Catherine Lempesis, Spring Valley High; Boys' 1A- H. M. Dixon, Hannah-Pamplico High; Boys' 2A- Ted Whitaker; Boys' 3A-Bob Reynolds, Flora High; Boys' 4A-Allan Ware, Greenwood High.
- 1:12= Coach Mike Moore of Irmo High asked for more volunteer help at the state track meet. Four coaches courageously volunteered: Coach Whitaker, Coach Lempesis, Coach Barry Knight of Wren High, and Coach Sullivan of Belton-Honea Path High.
- 1:22= Coach John Jones of Spring Valley High presented a ten items list to be "discussed" pertaining to the state meet series. Since most of the items had already been previously suggested, or was out of order for a short business meeting; President Kilbreth asked the membership to write out their thoughts about each of the items on the handout, and return the handout at the conclusion of the meeting. One proposal was voted on by the membership and passed. It asked President Kilbreth to request the High School League to place in the bulletin about any required rules clinic for the future.

- 2:20= President Kilbreth adjorned the meeting.
