Subject: Minutes of the summer clinic

17:00- President Ed Boehmke open the summer clinic of the South Carolina Track & Cross Country Coaches Association.

17:02- Mr. Pete Ayoub, executive director- South Carolina High School League, went over some existing rules of the League and some new National Federation rules. He emphasized the importance of every track coach obtaining a "current" rule book and casebook. Other concerns of his:

- a. Schools are limited to 16 track meets.
- b. Indoor track meets are approved but must count against your 16 fixture limit.
- c. First indoor fixture must be after the end of the first semester.
- d. If you want to schedule an indoor fixture before the first semester ends, then you must contact the League office.
- e. Rule 3-2-8. "May only use video equipment pre-authorized by the games committee to make decisions related to the meet."
- f. Do not look for reasons to DQ athletes.

17:43- Minutes and treasures report was given by LF Sanders, Allendale-Fairfax High. An amendment was made on the winter clinic minutes, to change the wording on whom gets a financial amenity: the site director. Coach Jim Kilbreth moved. Motion pass.

17:52- Coach Rut Dingle, Sumter High, gave a national competition report. Under this plan a school's coach could get \$50.00 per school year to off-set expenses of sending an athlete(s) to post national championships. The coach would not get the money if the athlete's expenses were being paid. President Boehmke and Coach Dingle voiced their objections to such a plan. The plan was table for a future date.

18:04- Coach Mike Moore gave a report on the Coaches Classic Track fixture. He stated that he would be glad to direct the meet for 1993.

18:06- President Boehmke reported on the State Track Meet. He thought it was the best one. There were 6 new state records set. A motion was submitted by Coach Frank Wendt, Johnson High. "Request more financial reimbursement from the SCHSL for running off the State Track Meet (\$2000.00)." It was seconded by Coach Bee Hightower of Fairfield Central High. It pass. Coach Moore, Coach Carlisle Koonts of North August High, Coach Jim Crawford of Crescent High, and Coach Wendt are to form a committee to check into this matter.

18:13- SCTCCCA COY awards for track were given out by Coach Bob Jenkins of Northwestern High. Boys' 4A- William Boroff, Laurens District 55 High (absent); Girls' 4A- Catherine Lempesis, Spring Valley High (absent again);

Boys' 3A- Henry Stradford, Camden High; Girls' 3A- Ted Whitaker, Hilton Head High; Boys' 2A- Al Young, Silver Bluff High; Girls' 2A- Tammy Schofield, Hampton(Hampton) High; Boys' 1A- Steve Phillips, Johnsonville High(absent); Girls' 1A- Steve Phillips, Johnsonville High(Whoops, he's still absent).

18:20- Coach Ron Sullivan of Belton-Honea Path High announce the SCACA COY= Boys'- Coach Mark Bedenbaugh of Pelion High. Girls'- Coach Phillips.

18:21- President Boehmke went over the upcoming cross country calendar. Motion was presented by Coach John Jones of Spring Valley High. " Move the winter clinic to the next to last week-end(23 Jan.) in January." It was seconded by Coach Kilbreth. There was only one objection vote, the motion pass.

18:40- Coach Willie Wooden of Riverside High conducted the Shrine Bowl Run.Coach Election. Joining Coach Eileen Kilbreth of Spartanburg High is Coach Sullivan. Coach Moore made a motion: " Change the selection number for picking how many seniors will run in the Shrine Bowl Run to 20 senior boys, and 5 senior girls." Coach Chris Thibaudeau of Lower Richland High second the motion. It pass with only one opposing vote.

19:00- Elections of Officers for a two year term:
President: Bob Jenkins
VP'S: Ron Sullivan, Ted Whitaker, and Willie Wooden.

19:10- Motion by Coach Thibaudeau: " Ask the SCHSL to increase the medals awarded at the State cross country championships for the individuals to 15 for each classification, each race." Coach Wendt seconded. It pass with no objections. Motion by Coach Jones: " Request the SCHSL to require a mandatory track rules clinic for all SCHSL high school track coaches." Motion was seconded by Coach Ed Boehmke of Eastside High. The motion pass without any objections.

19:20- Newly elected President Jenkins adjourn the meeting.
