Subject: Minutes from the winter clinic

- 10:04- President Kilbreth opened the winter clinic of the SCTCCCA. He announced the winners of the coach of the year awards in cross country from the association: Coach Ed Boehmke, Eastside High-Boys' 4A; Coach Catherine Lempesis, Spring Valley High-Girls' Open; and Coach Willie Wooden, Riverside High-Boys' 3A.
- 10:06- The minutes of the summer clinic and a financial statement was given by LF Sanders, Bell Street Middle. For the year 1987 the association started with a bank balance of \$1639.67. We took in \$2771.69 and took out \$1767.42 for a balance of \$3634.94 in the black. Coach Bob Jenkins of Northwestern High moved that the association accept the minutes as written, Coach John Jones of Spring Valley High seconded. It passed.
- 10:10- All members present voted on the cross country coach of the year for the parent organization(SCCA). Coach Boehmke for the boys and Coach Lempesis for the girls won by a large margin.
- 10:15- Coach Jones presented a final wrap-up of the cross country season. Coach Jenkins proposed that the association ask the 4A athletic directors to increase the qualifying teams from the present 3 teams to 4 teams for 1988. Coach Rut Dingle of Sumter High seconded. It passed. Coach Jones asked for volunteers to help make a program for the state cross country meet.
- 10:33- Coach Boehmke gave a report about the Clemson indoor fixture. He stated that the association will be asked to help officiate. Coach Boehmke also reported on the upcoming TAC certification.
- 10:41- Coach Steve Wilson of Socastee High reported on the status of the Coaches Classic held each year at Socastee. He reported that the community he serves is getting involed with this meet. Coach Ed Parker of Hanna High proposed that all running events held at the finals of the Coaches Classic be based on place first, then time. Coach Jenkins seconded. It passed by a vote of 21-7.
- 11:19- Coach Mike Moore of Irmo High gave a called for people to sign up to work the state track meet. He will not be the meet director, but will be the Columbia contact director. Coach Moore gave a report on the Shrine Bowl Run. The run raised \$20,000 for charity.
- 11:27- Coach Delmer Howell of Mauldin High was on the agenda to report on the use of qualifying standards for the state meet series. He was conspicuously absent.
- 11:31- LF Sanders reported on the new rule changes. All the changes discussed were from the 1988 National Federalization track

11:52- President Kilbreth reported on the approved fixtures for the year. Coach Harold Jones of Hanna High proposed that the association asked the SCHSL to conduct the state track finals on the third week~~end~~ of May, and that all other qualifying meets would be set up accordingly. Coach Jenkins seconded. It passed.

12:03- President Kilbreth reminded all present that elections for officers will be done at the summer clinic. He then adjourned the meeting.
