- 10:09- President Ed Boehmke open the winter clinic of the SCTCCCA held at Spring Valley High, Columbia, SC.
- 10:12- The minutes from the summer clinic and a financial report was given by LF Sanders, Lugoff-Elgin High School. For the year 1988, the association started with a balance of \$3634.94. The association took in \$6057.00 and took out \$3940.69, leaving a balance of \$5751.25 in the black. Coach Jim Kilbreth of Spartanburg High moved that the minutes be approved as written. Coach David Pratt second. It pass.
- 10:15- President Boehmke told the membership that work is being done on the All-State awards.
- 10:16- President Boehmke thank all those coaches who help work the cross country state meet. The state meet site for cross country may have to be moved to another location. It also may be split for girls if the number of teams show at least 16 teams in the 3A-2A-1A. Next year state meet will be on November 4. A motion from the floor was given by Coach Kilbreth: That the state cross country meet be held on the first Saturday in November. It was second by Coach Cathy Lempesis of Spring Valley High. It pass on a 24-3 hand vote. It seems that Fort Jackson as a future site for the state meet. Coach Kilbreth recommanded that the association form a committee to find a location within 30 miles to Columbia. President Boehmke suggested that the state meet site could be rotated.
- 10:52- The ballots for picking the cross country coaches of the year for the parent organization(SCACA) was given out.
- 10:55- The new rules from the 1989 rules book was presented by Coach Sanders. A new video from the SCHSL on rules can be obtain from SCHSL.
- 12:18- Coach Kilbreth announced the cross country coaches of the year from the association: Coach Boehmke, Eastside High- Boys'4A; Coach Lempesis, Spring Valley High- Girls'Open; and Coach Willie Wooden, Riverside High- Boys' 3A. Coach Kilbreth was given a plaque honoring his service as president of the association for the past two years. The winners of the balloting for the coaches of the year from the parent organization: Coach Boehmke for the boys' and Coach Lempesis for the girls'.
- 12:21- Coach Steve Wilson of Socastee High gave a report on the 1989 Coaches Classic. He moved that the association take the 8 regional winners then the next best times for seeding the 800m and on up. Coach Kilbreth second it. It pass. Coach Wilson stated that awards will be a plaque for 1st place, and medals for 2nd thru 4th place. The <u>High School Sports Report</u> wants to do individual reports on any returning state champions. Coach Crumley moved that the Coaches Classic take 8 to the finals in the field events. Coach Pratt second it. It pass.
- 12:47- President Boehmke presented information about other track meets and the state meet series. Coach Hercules Salley of Orangeburg-Wilkinson High moved that the association ask the SCHSL to add the following events to

the state meet series:  $4 \times 200 \text{m}$  Relay and the  $4 \times 800 \text{m}$  Relay. Coach Larry Bost of Lexington High second it. It was opposed by a hand vote of 20-12.
