Subject: Minutes of the winter clinic

10:25- President Bob Jenkins, Northwestern High, open the winter clinic.

10:30- LF Sanders, Allendale-Fairfax High, gave the minutes and financial report. The association has \$4300.80. Mr. Sanders stated that the membership in the association is now at 207 members. Ted Whitaker, Hilton Head High moved the reports be accepted, Rut Dingle, Sumter High, seconded. It pass.

10:36- Ed Boehmke, Eastside High, gave a review of the 1992 cross country season.

10:37- Shrine Bowl Run report. Coach Jim Kilbreth, Spartanburg High, gave the report in the absence of his wife Coach Eileen Kilbreth. Coach Kilbreth stated that by cutting down on the number of people running-- that cut down the number of problems. He praised Ron Sullvian, Belton-Honea Path High, for his help. There were 25 athletes- 3 of whom were girls.

10:42- Cross country dates for 1993. This was done by Willie Wooden, Riverside High.

10:47- Ron Sullivan gave out the SCTCCCA coach of the year awards for cross country: Boys' 4A- Mike Moore, Irmo High; Girls' 4A- Delmer Howell, Mauldin High; Boys' 3A- Willie Wooden(this is getting to be ridiculous); Boys' 2A- Frank Morehead, N. Myrtle Beach High; and (in a long time coming) Girls' 3A- Jack LeGrand, Chapin High.

10:50- SCACA coach of the year. President Jenkins, in an effort to abide with the SCACA, stated that our association needed a constitutional change for COY.(10A#4, 10B#5) The parent organization wanted 3 names from our association. Coach Dingle so moved with Coach Jack Meetze, James Island High, seconded. It pass. The names: Delmar Howell, Jack LeGrand, and Ron Sullivan for the girls'; Mike Moore, Willie Wooden, and Coach Rick Zeller of Wade Hampton(G) for the boys'. Coach Chuck Parker moved that for the SCACA COY for track that each region decide the award. Coach Bost seconded. Voting went 12 yes, 16 no. It failed. Coach John Jones, Spring Valley High, moved that each region submit one name for COY, they are turn in to the state meet director, the top three names from this association from the state meet are chosen. Coach Parker seconded. It pass with only 2 opposing votes.

12:02- President Jenkins reported on the dual meet championship survey. He stated that the greatest number of responses did not want a change. Coach Dingle moved that a committee to be

  Coach Whitaker moved that the association actively pursue getting the SCHSL to approve a state indoor season. Coach Boehmke seconded. It pass. A report will be presented to SCHSL by this group.
- 12:40- Invitationals for the coming track season was presented on a calendar by Coach Boehmke.
- 12:51- Coaches Classic- Coach Boehmke, Coach Moore.
  The following schools will host the qualfying meets: Eastside,
  Broome, Northwestern, Spring Valley, Orangeburg-W, Francis
  Marion, and Summerville.
- 13:03- State Meet- Coach Jones. President Jenkins reported that the pay for upper/lower state meet directors will be increase. Coach Ed Boehmke moved that \$250.00 be paid to the site management director. Coach Rob Nelson, Rock Hill High, seconded. It pass. Coach Whitaker moved that the number of qualfying athletes from the regions(3A,2A,1A) to the upper/lower state meets, be increase from 3 to 4. Coach Bryant Childs, Holly Hill-R, seconded. It pass. Coach Dan Shonka, Daniel High, moved that a Trackmaster be used to measure and approve the field events implements at the state championships. Coach Chris Thibaudeau, Lower Richland High, seconded. Vote= 12-Yes, 11-No. It pass. Coach Shonka stated that an assistant coach from Clemson University will be present to do the measuring. (This motion, in effect, has given approval for athletes to bring their own shots and discus) Coach Whitaker moved that at any qualifying meet, if there is not a Trackmaster(or someone who got enough brains to know how to use it) present, then the athletes must use the implements provided by the meet mangement. It was seconded by Coach Nelson. It pass. Coach Jones moved that all state championships trophies should be the same size. Coach Whitaker seconded. It pass.
- 13:30- Coach Sanders went over the new rule changes.
- 14:00- Coach Boehmke moved that the state meet be scored for 7 places. Coach Bob Lake, Easley High, seconded. Vote= 16-Yes, 6-No. It pass.
- 14:04- Several committee reports were given by Coach Moore, Whitaker, and Jones with no action taken on any of them.
- 14:11- President Jenkins adjourn the meeting.
