- 10:49- Steve Wilson(Summerville) gave out the COY awards for cross country: Boys 4A- Rob Wilder(not present), Girls 4A- Eileen Kilbreth(Spartanburg), Boys 3A- Rick Zeller (Hampton-G), Boys and Girls 2A- Mike Davis(Pendleton) (not present). Special awards were given to Carre Joyce of Summerville(it was awarded to Carre at the Summerville basketball game on the 21 Jan., 2000) and to David Adams of Hilton Head(David was sick and did not attend).
- 10:55- Coach Boehmke talk about his tracksite on the web. Coach Bobby Urban(Dorman) moved that the Association pay Coach Boehmke \$400.00 a year to place our track info. 2nd= Chuck Parker (Hanna). IT PASS,
- 10:59- President Shaw ask the Association for permission to contract with Carolina Sports Shots. This group will take pictures at the State track and XC meets.
- 11:07- John Blackburn(SCUSA T&F Officals Chair) gave out info about the Nike indoor and NSO meets.
- 11:20- Coach Boehmke went over the track schedule for this spring.
- 11:33- President Shaw talk about the Coaches Classic Track.

- 11:49- President Shaw went over a proposed incomes & expenditures for running the state meet. Coach Jenkins moved that the HSL pay the head event judge \$100.00. 2nd Coach Huggins. It pass.

 Coach Jenkins moved that the Association contract T-shirt sale from the HSL. 2nd= Delmer Howell(Mauldin). It pass.
- 12:27- A short time was spent on determining the date for the Coaches Classic Cross Country meet. It was decided on the 16 Sept., 2000. Coach Jeff Buys(Ridge View) and Coach Griffin presented 4 proposals on how to run the Coaches Classic XC. Proposal 3 won. This proposal will leave the varsity races unchanged, but split the JV races into 2: 7-9 graders, and 10th graders. Coach Jones moved that the 7-9 JV race start first, follow by the varsity races, then end with the last JV race. 2nd= Coach Bost. It pass with 3 votes against.
- 13:00- Coach Chris Worrick(Belton-HP) moved that schools be allow to bring their complete team to the State track meet. The eligibility list would be used. 2nd= Jackie O'Rourke (Wando). It pass. Coach Jones moved that if the HSL does not accept Coach Worrick's plan then allow those athletes who competed at the region meet bealtow in. 2nd= Tom Cronin (Spring Valley). It pass.
