The association would then be reimbursed up to \$5,000 by adding a surcharge to the Coaches Classic cross country meet.

That all non-region winning teams in all classes meet at the Sandhills course the Saturday prior to the state meet to compete to determine the remaining qualifying spots.

That an open race be held at this qualifying meet for the JV's to run in.
