# SOUTH CAROLINA TRACK AND CROSS COUNTRY COACHES ASSOCIATION MIKE MOORE SHRINE BOWL BALL RUN BY-LAWS

### I. MMSBBR committee members

- A. Current SCTCCCA President
- B. Current SCTCCCA MMSBBR Chair (appointed, presiding officer)
- B. Current SCTCCCA Head Coach (previous years Assistant Coach)
- C. Current SCTCCCA Assistant Coach (next year's Head Coach)

# II. Selection Criteria

The selection criteria will be three-fold and are listed below.

- A. Application submitted completely and by the deadline.
- B. Applicant must compete in the Cross Country State Championships.
- C. Applicant must meet time requirement at the State Championships:
  - (a) Committee may adjust times based on weather conditions
  - (b) Committee may go beyond time requirement to fill roster.
  - (c) Committee may forego criteria 1, if a State Champion did not apply.
  - (d) Committee will assign next fastest runner from the State Championship (if applied), if a runner was to turn down the opportunity to run more than 10 days from the event.
  - (e) Committee may assign any applicant a slot if someone were to pull-out within 10 days of the event.

# III. Application procedures.

- A. Runners must apply online by set deadline (Monday 3pm, prior to State).
- B. Application must be complete and on time. Applications are time stamped when submitted.

### IV. Route

- A. Runners are placed throughout the course randomly.
- B. Runners are matched up first with teammates and assigned a letter.
- C. Remaining runners are grouped randomly and assigned a letter.
- D. Leg 1 alternates between B/G highest Team finish at State.(a) If a former Shriner Kid is on the team, this leg will be assigned to them and their partner.
  - (b) Committee may assign this leg due to special circumstances that is brought before the committee.
- E. Leg 17, is assigned to the fastest 2 boys (due to length and terrain).
- F. All other legs are assigned randomly

- G. Handoff in the stadium is assigned using the highest criteria:
  - (a) Former Shriner Kid
  - (b) Special circumstances presented to committee
  - (c) State Champions
  - (d) Fastest Male/Female
  - (e) Committee selection
- H. Run course slots may change prior to run due to runners pulling out, runners not showing, runners needing to leave early, or special circumstances brought before the committee.

## V. Gear

- A. Each runner will receive a Run Hoodie & Run Shirt the morning of the run.
- B. Runners may not wear any school issued uniform during the run.

### VI. Coaches

- A. Head Coach & Assistant Coach (both voted positions) compile team at State Championships.
- B. HC/AC contact runners to confirm spot on team and sizes.
- C. HC contacts Shriner Committee to confirm dates and times.
- D. HC sets bus transport with a local school.
- E. HC/AC transport runners from leg to leg throughout the morning.
- F. HC/AC attends pre-game lunch and ceremony on the field.
- G. HC/AC setups any return trips to hospital prior to event date.

### MMSBBR Chair

- A. Collects applications online.
- B. Confirms team with Head Coach
- C. Orders Team Gear 3 weeks from event
- D. Drops off Team Gear the morning of
- E. Speaks to parents about the route and the procedures of the day, during hospital visit.
- F. Assists the HC/AC as needed from State Championship through end of event.

# VII. Funding:

- A. The SCTCCCA will cover the cost of Team Hoodies and Shirt.
- B. If a sponsor is found, the cost of the Team Hoodies and Shirt will be donated to the Shriners Hospital in Teams Name.
- C. Head Coach, Assistant Coach, and MMSBBR Chair will be reimbursed 45 miles of gas, per current SCDOT mileage rate.
