Rachel Lindman (Spring Valley)	Constitution/by-laws/operating codes	Proposed that the body vote to create a committee to merge/collaborate by-laws from all SCTCCCA events/scholarships to create a single document constitution/by-laws/operating codes in an effort to mainstream the operations of our association allowing new members to understand how and why we do what we do.

Chris Price (Rock Hill)	Region qualifying meets for high jump and pole vault	Proposed that during all region qualifying meets, all classifications (1A-5A), in the vertical jumps of high jump and pole vault those that qualify to move forward to the State Qualifiers and/or Upper/Lower State must be first in the event or meet a qualifying standard.
Chris White (Seneca)	Voting for the HOF	Proposal to change the format of voting for SCTCCCA Hall of Fame from a Hall of Fame Meeting to an anonymous vote by email OR paper ballot sent to all voting members (current Hall of Famers and SCTCCCA board) to be completed in the month of July. Resumes for all nominees will be presented to voters, and they will vote "yes" or "no" for each. Nominees must obtain 75% "yes" vote to be elected. In a case that more than 2 nominees receive over 75%, the top 2 vote getters will be elected. Nominees will be dropped from the pool after 10 years of not being elected.
Matt Oberly (Spring Valley)	Implementation of the javelin event	Proposed that javelin is implemented into the state series by a three year process, with the 2020 season serving as the 2nd year. The first official season with javelin in the state series is the 2022 season.
